Welcome to Padel Dome!

These Terms and Conditions apply to your access to and use of our website and booking platforms/app, encompassing any content, features, and services provided through our website (collectively referred to as the "Website"). By utilizing our Website and App Platform, you agree to adhere to these terms.

Intellectual Property Rights

- The Provider reserves the right to refuse service, terminate bookings, or deny access to the Facility to any customer who breaches this Agreement, engages in unsafe behavior, or poses a risk to the safety of others or the Facility.

Dispute Resolution

Disputes arising from these Terms and Conditions will be resolved through the following steps:

1. Negotiation: Initially, the parties will attempt to resolve any disputes amicably by negotiating in good faith.
2. Mediation: If negotiation is unsuccessful, the parties will proceed to mediation under the Mediation Act 2017.

Padel Terms of Play

1. Acceptance of Terms

By booking, accessing, or participating in any padel activity at Dublin Sport Dome, all players and guests agree to comply with these Terms of Play and our General Terms and Conditions, and any instructions provided by staff.

2. Eligibility to Play

2.1 Players participate at their own risk.

2.2 Players under the age of 18 must have the consent of a parent or legal guardian and be supervised if under 16 years of age.

2.3 The Club reserves the right to refuse access to any person whose behaviour is considered unsafe, disruptive, abusive, or otherwise unsuitable.

3. Health and Fitness

3.1 Players are responsible for ensuring they are physically fit and medically able to participate in padel activities.

3.2 Players should not participate if they are suffering from any illness, injury, or condition that may affect their ability to play safely.

3.3 Dublin Sports Dome accepts no responsibility for injuries arising from a player's failure to assess their own fitness or medical condition.

4. Court Conduct

4.1 Players must conduct themselves in a respectful and sportsmanlike manner at all times.

4.2 Abusive, threatening, discriminatory, or offensive behaviour towards staff, coaches, officials, or other players is strictly prohibited.

4.3 Players must comply with all safety notices, court rules, and directions issued by Dublin Sports Dome personnel.

4.4 Dublin Sports Dome reserves the right to remove any player from the premises without refund where behaviour is deemed inappropriate or unsafe.

5. Equipment and Attire

5.1 Appropriate sports clothing and non-marking court shoes must be worn while using the courts.

5.2 Players are responsible for ensuring that all personal equipment is safe and suitable for play.

5.3 Dublin Sports Dome may prohibit the use of equipment that it considers unsafe or likely to damage Club facilities.

6. Court Bookings and Use

6.1 Players must vacate the court promptly at the end of their booked session.

6.2 Court bookings are non-transferable unless otherwise approved by Dublin Sports Dome.

6.3 Dublin Sports Dome reserves the right to cancel, amend, or reallocate court bookings due to maintenance requirements, tournaments, coaching programmes, adverse weather conditions, or circumstances beyond its reasonable control.

7. Safety Requirements

7.1 Players must exercise reasonable care to avoid injury to themselves and others.

7.2 Players should remain aware of surrounding players, glass walls, fencing, gates, and court fixtures.

7.3 Any accident, injury, defect, or unsafe condition must be reported to a staff member of Dublin Sports Dome immediately.

7.4 Players must not enter a court while another match or session is in progress without permission.

8. Coaching and Instruction

8.1 Only coaches authorised by Dublin Sports Dome may provide paid coaching services on Club premises.

8.2 Dublin Sports Dome reserves the right to restrict or prohibit unauthorised coaching activities.

9. Personal Property

9.1 Players are responsible for their own personal belongings.

9.2 Dublin Sports Dome shall not be liable for the loss, theft, or damage of personal property brought onto Club premises.

10. Liability

10.1 Participation in padel involves inherent risks, including the risk of personal injury.

10.2 To the fullest extent permitted by law, Dublin Sport Dome shall not be liable for any injury, loss, damage, cost, or expense suffered by a player arising from participation in padel activities, except where caused by Dublin Sports Dome's negligence or where liability cannot be excluded by law.

10.3 Players are responsible for any damage caused to Dublin Sports Dome property through wilful misconduct, negligence, or misuse.

11. Photography and Recording

11.1 Dublin Sports Dome may take photographs or video recordings for promotional, training, or operational purposes.

11.2 Any player who does not wish to appear in such materials should notify Dublin Sports Dome in writing.

12. Amendments

Dublin Sports Dome reserves the right to amend these Terms of Play at any time. Updated terms will be made available through Dublin Sports Dome's website or at our premises and shall take effect upon publication.
